Workshop Topics:

Budget Prep: Ms. Lucas printed out worksheets to start the process and has been filling in the line items herself. She gave all Commissioner copies and asked them for input too. Will also go over with Commissioner Mark. All Commissioner's suggested we invite Ex-Commissioner Mirras to help in the process. Ms. Lucas said he has been helping Commissioner Mark with the process but will call to see if he is available for our next meeting.

Gator Site Update: As per Chief Snow, at last Town Chief's meeting they were told by Eddie Schnell the materials are just sitting up there but nothing has been done. It was suggested to invite Eddie Schnell to next meeting and see if there has been any progress.

Operating Procedures for 9-3-81: As of today no changes to the policy. The original policy is till in affect until the District makes any changes. This policy should be adhered to.

As per Commissioner Pitts;

- New Chief's Vehicle is just waiting on a CO charger which John ordered then it will be completely done.
- Chief' Snow's vehicle is getting stripped down.
- The old 9-3-30 needs some work, no AC and a check engine light is on.
- 9-3-7 will hopefully be back tomorrow.
- A request was presented from the fly car committee for items still needed for the vehicle, seat covers to protect the seats and floor mats. The floor mats were already approved earlier in meeting. Commissioner Schoen questioned where the requests were coming from. The requests should come from the Chief.
- A community member contacted Commissioner Pitts about his friend going into full arrest last night and he was really impressed and thrilled to live in Montauk. They responded fast and were professional. He said at 10am this morning his friend is still alive. Chairman Dryer said it was a complement to Company 4 and its members and we thank you for that. He has always talked about them being the angels of the firehouse. Chief Snow stated the backbone of the firehouse. They have been doing some great work.

As per Commissioner Wright the two dead trees were removed and he will talk with Brent about when to put the new ones in, he feels August is not the right time. Also John Tanzi will get back to us with a proposal about the steel at the front of the bays.

Commissioner Schoen questioned the emergency purchase on air conditioners for the ambulances what about 9-3-80 and 9-3-81 do they carry the same drugs. There are provisions for that already, the boxes in those vehicles are already refrigerated. Also at last meeting Commissioner Schoen asked about class B foam, did we hear anything about it. Chief Snow wasn't given a report will have to wait for Chief Valcich for this information.

Ms. Lucas discussed service contracts on the stretchers. The other day company 4 was having an issue with one of them. The service guy came out and found the stretcher in 9-3-18 was malfunctioning because of a manufacturer defect. One of the contacts wasn't properly secured. He fixed it and also checked 9-3-17, that one was good. He wasn't able to check 9-3-16 because it was on a call. He will be back to do the preventative maintenance in September.

Chief's Report

- The other night there was a car accident/fire, everybody did a great job.
- 9-3-5 had to be jump started, it had a dead battery. Commissioner Pitts said it was taken care of they had to put a new charger in and reconfigure it. He said the members should be starting these vehicles more often.
- We did a mutual aid to Springs and stood by for them.
- EMS personal are doing a great job, its always impressive how Montauk pulls it out.
- Town Chief's dinner is actually 1st Tuesday in September will that be OK. It shouldn't be a problem depending upon the state mandate.
